Eligibility	Domestic or international graduate students registered full-time and with a minimum 80% average. Students must be contributing to civil society through international field work that is part of a course of study. Preference is given to students working in Africa.

How to apply	Apply to the Office of Graduate and Postdoctoral Studies Awards Committee by May 1 with a CV, a one-page summary of research proposal, a letter of reference and a one-page letter outlining extracurricular and volunteer involvement in international field work. ### Arrell Scholarship

Value	\$50,000 per year for 2 years (MSc) or 4 years (PhD)
Sponsor	University of Guelph – Arrell Food Institute
Type	Entrance
Eligibility	Exceptional Canadian or international students working in a relevant research area (food, nutrition, sustainable agriculture, crop science, etc.). Minimum A- admission average.
Adjudication	Office of Graduate and Postdoctoral Studies Awards Committee

### Brock Doctoral Scholarship

Value	\$37,500/year for up to four years

Eligibility	Domestic or international students entering or transferring to a full-time doctoral program in May, September, or January following the deadline date. Students must demonstrate outstanding academic performance, leadership and/or service, and teaching and research skills and potential.

How to apply	Students apply to their College Dean by the deadline submitting the following in a single PDF file: curriculum vitae; a one-page personal statement; transcripts; 3 letters of reference; documentation of teaching, research, volunteer activities and leadership. The College will then nominate a candidate and submit their documentation, along with a letter of support from the Dean, to the Office of Graduate and Postdoctoral Studies.

Eligibility	Canadian citizens or permanent residents who self-identify as a member of the BIPOC (Black, Indigenous and People of Colour) community and who are planning to enter a MSc thesis program in CBS.
Adjudication	Associate Dean, Research and Graduate Studies plus a committee of faculty representatives from CBS Departmental EDI committees
How to apply	To apply, students should submit: 1) a completed and signed <a href="#">eligibility confirmation form</a> ; 2) A 2-page personal statement that describes: (i) Why you are interested in doing research; (ii) What kind(s) of scientific questions are you interested in exploring in your MSc research; (iii) Your long-term career interests and goals; (iv) Your leadership activities (which may take a variety of different forms including, but not limited to: work experience, volunteering, extracurricular activities, etc.) (v) The 3 accomplishments you are most proud of (this can be anything!).
